Maverick Holding SA, a corporation enrolled in the National Registry of Legal Entities of the Ministry of Finance ("CNPJ / MF") under number 16.855.255 / 0001-76, with its registered office at Rua México nº 03, 9º andar - parte, City and State of Rio de Janeiro, CEP 20.031-144 ("Maverick"), in compliance with art. 12 of CVM Instruction 358 of January 3, 2002, announces that, on this date, it transferred nine hundred and forty-five thousand, seven hundred and twelve (945,712) shares, representing 32.61% (thirty-two integers and sixty-one hundredths percent) of the issued shares of MLog S.A., to Nortegrãos Operadora Logística S.A. (future Lion Investimentos SA), a corporation enrolled with the CPNJ / MF under No. 26.421.417/0001-11, with its registered office at Rua México, nº 03, 9º andar - parte, City and State of Rio de Janeiro, CEP 20.031-144 ("Lion").

2. As a result of the abovementioned transfer of shares, Maverick became the direct holder of 593,474 (five hundred and ninety-three thousand, four hundred and seventy-four) shares representing 20.47% (twenty integers and forty seven hundredths per cent) of the issued shares of MLog S.A. Lion, in turn, became the direct owner of 945,712 (nine hundred and forty-five thousand, seven hundred and twelve) shares representing 32.61% (thirty-two integers and sixty-one hundredths percent) of the issued shares of MLog S.A.

3. Lion's capital is fully owned by Maverick and therefore the above-mentioned share transfer does not change the composition of the MLog S.A. control and will not change its management structure.
